In accordance with [F.S. 98.075\(7\)](#), you are hereby notified that your eligibility to vote is in question. You are required to contact the Supervisor of Elections in Pinellas County, Florida, no later than thirty (30) days after the date of this publishing. Failure to respond may result in a determination of ineligibility by the Supervisor, and your name will be removed from the statewide voter registration system. If you believe this information is incorrect, you may request a hearing to provide evidence of your eligibility to vote. If you attempt to vote at an early voting site or your normal election day polling place, you will be required to vote a provisional ballot. If you vote by mail, your ballot will be treated as a provisional ballot. In either case, your ballot may not be counted until a final determination of eligibility is made. If you wish for your ballot to be counted, you must contact the Supervisor of Elections office within two (2) days after the election and present evidence that you are eligible to vote. Conforme al Estatuto de Florida (Florida Statute, F.S.) 98.075(7), se le notifica por este medio que su elegibilidad para votar está en duda. Debe comunicarse con la Supervisora Electoral del Condado de Pinellas, a más tardar treinta (30) días después de la fecha de esta publicación. No responder puede resultar en que la Supervisora determine que no es elegible y en que se elimine su nombre del sistema de registro de votantes. Si considera que la información es incorrecta, puede solicitar una audiencia para proporcionar evidencia de que usted es elegible para votar. Si intenta votar en un centro de votación anticipada o en su centro de votación normal el día de las elecciones, se le pedirá que vote con una boleta provisional. Si vota por correo, su boleta será tratada como una boleta provisional. En cualquier caso, su boleta no puede ser contada hasta que se tome una determinación final de elegibilidad. Si desea que su boleta sea contada, debe comunicarse con la oficina de la supervisora electoral dentro de los 2 días posteriores a las elecciones y presentar evidencia de que es elegible para votar.
